

Yearly Report on research data management (RDM) and data support activities in 2018 and plans for 2019

2018 was a busy year for data support activities.

Reorganising data support

At the beginning of the year, there was a reorganization in which library personnel was transferred to work under new service units. Twelve information specialists started working in research services and Open Science and ACRIS (OSA) team. Half of the team joined school teams of research services in addition to taking care of their other duties in the team (importing and validating publications in ACRIS, bibliometric analysis and maintaining publication platform).

In the school teams, the main tasks of OSA team members are in advocating open access publishing, helping research with research data managing and opening data. OSA TEAM also helps with data management plans (DMP) and EU reporting. In addition to collaborating closely with colleagues from research services, OSA team plans RDM activities in school level with data agents.

Data agents (April 2019)

Data Agents are researchers who work to improve data management in their department, school, or unit. They are a first, practical, hands-on resource to researchers in their department. They

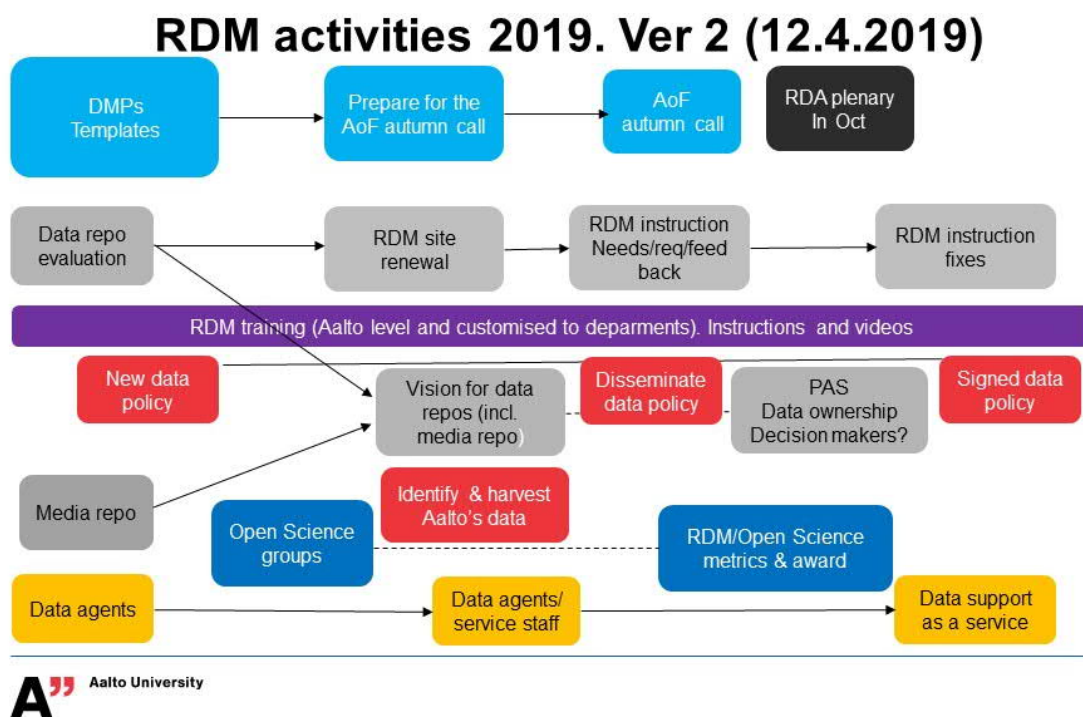

1. We are preparing for Academy of Finland autumn call by preparing DMP templates for different data types and arranging training events on DMPTuuli.
2. After the renewal of aalto.fi the RDM pages had to be updated and restructured.
3. After having arranged roadshows in school level and presentations in departments and research groups we arranged training at Aalto level and recorded the training.
4. New data policy is published in 2019.
5. Data repositories: The most used data repositories were evaluated. Planning for Aalto's media repository started. Efforts to identify data residing in international repositories by Aalto researchers were intensified.
6. Planning for rewarding opening data started.
7. The reorganisation of data support groups started by recruiting a full time data advisor for OSA team.
