- Debt behavior, financial distress, default, bankruptcy, and debt resettlement
- Saving for retirement and financial decision-making of the elderly
- Financial literacy, financial education, and interventions for better financial decision-making
- Expectations, beliefs, and preferences
- Financial advice and advisors
- Climate change, sustainability, and household financial decision-making
- Machine-learning, algorithms, and data-driven household finance
