

Changes in Activity Categories in 2022

Activities categories have been updated. We have added subcategories that researchers have requested, and updated the activities based on [TENK's CV model](#). Some subcategories were outdated and they have been removed.

The concrete changes are the following:

Publication peer-review and editorial work

- **Added:** A new subcategory *Editor-in chief in journal or in book series* has been created to enhance the importance of this activity.
- **Removed:** *Editorship of a book or a special issue of a journal* (now in Research Outputs), *Translation work* and *Curatorship of an exhibition or producer of a production*.

Participating in or organising an event

- **Added:** To showcase your societal impact, two subcategories we added. *Organization of an event for a non-academic audience* (public outreach) and *School engagement* (activities involving e.g. lecturing to high school students or school groups visiting Aalto.)
- Note that visiting infrastructures has its own subcategory under other activities: *Short group visit to research infrastructure*

Talk or presentation

- **Added:** A new category, *Public talk to non-academic audience (public outreach)*.
- **Modified:** Invited talks are specified as *Invited academic talks*.

Commercial, industrial or non-academic activities

- **Added:** We wish to offer a place to record entrepreneurial activities and have added a new subcategory *Starting your own company*.
- **Modified:** We specified that *Consultancy and expert advice (including statements)* consists of non-academic activities (even though e.g. statements for ministries are based on academic expertise). We have moved academic advising activities to proper subcategories, mostly to supervisor work, memberships or academic assessment.

Memberships (typically long-term positions of trust)

- **Modified:** There is now a subcategory *Membership of a competition jury* and the contents of the former subcategory: *Membership of a jury* is moved to correct subcategories.

Academic assessments

This category includes several modifications and new subcategories. Even the name of the category has been changed from *Examination* (typically short-term assignments) to *Academic assessments*.

- **Added**
 - *Leadership experience in research groups or projects* is based on TENK CV.
 - *Evaluation of other than Doctoral thesis* (e.g. Licentiate, Master's)
 - *Appointed supervisor or advisor of postgraduates at Higher Education Institutions.*
 - *Appointed supervisor or advisor of undergraduates at Higher Education Institutions.*

Note that all Aalto's doctoral theses supervised or advised in and after 2010 are automatically integrated to your profile (if the doctoral candidate has allowed the integration). However, the above subcategories can be used when you have supervised or advised postgraduates in other universities or supervised Bachelor's or Master's students at Aalto or elsewhere. The number of supervised undergraduate students and when and where the supervision took place is sufficient, so the names of the students are not needed.

- **Modified:** There are now two subcategories for evaluation of academic activities: *Evaluation of significant academic activities* and *Evaluation of other academic activities*. Use significant subcategory when you are e.g. evaluating education programmes, research activities in universities, department activities etc.

Other activities

- **Added**
 - *Teaching merits*. You can add e.g. pedagogical training, research-based and collaborative development of teaching and teaching methods, teaching experience etc.
 - *Other expert tasks or merit*. This is the place for all the other merits, e.g. promoting responsible research or open science. Please add artist residency programs to Prizes -> Granted funding (personal grants)

Prizes

- **Added:** Two subcategories: *Granted funding (personal grants)* and *Granted funding (public project funding)* are added. Public project funding should be added only by the PI of the project.

Press / Media

No changes
