1. How to improve student experience for international students? Focus on journey.

Higher education institutions have set out to implement Talent Boost measures to promote internationalisation through strategy funding. One of the measures of the National Talent Boost is to integrate international talent in Finland.

For international students, integration is mainly initiated as soon as an acceptance notice is sent to the student who applied to the degree programme. Integration continues until graduation and sometimes beyond. Although HEIs have done a lot for years, there are still various challenges. In many HEIs, arrival and orientation are weak links. The second is the end of the path — the transition of students into employment. Higher education institutions have set out to develop the student's service path as a whole, specifically addressing its problem points. The trail review also aims to make the services provided seamless and improve the student experience. What kind of good solutions have already been found and what is the need for special investment right now? Come and discuss and share good practices.

Sessiossa käsitellään tapoja ja työkaluja, joilla korkeakoulut voivat tunnistaa kansainvälisen opiskelijarekrytoinnin kohderyhmät kustannustehokkaan ja pitkäjänteisen kv-opiskelijarekrytoinnin kehittämiseksi.

Suomalaisopiskelijoiden ulkomaanjaksojen määrä alkoi vähentyä jo ennen koronaa ja romahti pohjalukemiin koronan aikana. Aihetta on käsitelty useissa yhteyksissä ja taustalta on tunnistettu useita eri syitä. Nyt tavoitteena on pureutua syvemmin siihen, mitä esteiden poistamiseksi voidaan tehdä.

Sessiossa kuulemme alustukset aiheeseen sekä Opetushallituksesta että korkeakouluista/opiskelijajärjestöistä. Lisäksi pyrimme yhteistyöskentelyn keinoin tunnistamaan, mitä voimme yhdessä ja erikseen tehdä liikkuvuuslukujen laskusuunnan käänämiseksi. Sessio on jatkoa Oulun syyspäivien sessiolle ja materiaalina käytetään mm. syyspäivien sessiossa kerättyjä keinoja liikkuvuusmäärien kasvattamiseksi.

4. Unlocking the potentials of online learning for the internationalization of higher education

In 2019-2020 the Nordplus Higher Education Programme had a special highlight on the theme “Digital competence and computational thinking”. This resulted in an increased number of projects on digitalisation and on-line learning. As a main administrator for this programme, The Finnish National Agency for Education (EDUFI), commissioned a research team at University of Oulu to conduct a study on this phenomenon based on the proposals and final reports of these funded projects. In the session we present the main results of the study; the identified potentials of online learning as well as the requirements and challenges in designing online programs to ensure real intercultural learning experiences. Through concrete experiences presented by a practitioner from a granted Nordplus project, we share best practices on online learning with focus on e.g. preparation and development, design, pedagogy, teachers and students as well as learning materials.

5. Responsible partnerships - understanding due diligence

An increasing number of higher education institutions globally are developing academic partnerships for research and education purposes. It is in the interest of universities to take reasonable care to identify and mitigate risks in working with international partners, and due diligence processes are a critical step in safeguarding student and staff safety and potential reputational, legal and financial risks. In designing due diligence processes for academic purposes, universities should consider the specific characteristics of academic partnerships whilst drawing from existing good practice used in commercial/non-academic and donor due diligence and risk mitigation. The purpose of this session is to provide participants an opportunity to learn more about due diligence, discuss challenges and existing good practices in developing due diligence processes, rather than provide ready made answers and templates.

This session will provide an overview of:

- What due diligence is
- Why due diligence is important
- Approaches to due diligence
- Tools and best practice examples (at least) from the UK and Finland

The objective of the session is to:

- Bring together individuals who are interested in the development and implementation of due diligence processes
- Share best practices and tools
- Establish an informal working group and continue development of good practices collaboratively after the event.

9. "I'd love to stay but..." - how can we help international students to find employment in Finland?

The theme of the session is supporting international art, design and architecture students in their attempts to find employment after graduation. The problems graduates (and those searching for internship placements) face are related to the nature of work in those fields, e.g. building professional networks is very important already during the studies and a good command of Finnish/Swedish is often necessary.

In this session, we will discuss how we are helping international students now in their attempts to find employment, and what we could do to support them in this even more in the future.

The collaboration between University of the Arts Helsinki and Männikkömetsä is presented as a case study in how to support international students in finding employment in Finland.

10. International students face barriers to inclusion. What are we doing about this?

Having implemented an ambitious strategy to attract international degree students in the early 2010s, Aalto saw a dramatic increase in the international student population, particularly at master's and PhD levels. English is used in international degree programmes. However, the use of English and a Lingua Franca does not extend to social interactions. Results from surveys and interviews of Aalto students and staff revealed that many international students felt excluded from local social networks due to language-related issues.

In studies about international education, the social aspect of the integration of international students is often overlooked, while in research concerning social integration in student life, international students are understudied. In addition to concerns about international student inclusion in general, the panel invites discussion on intersectional accessibility needs and inclusion beyond academia in working life. This is directly one of the 2035 targets and a title of the session topics from OPH vision: 3. Finland, a responsible and receptive nation: Entering Finland and staying in

the country is smooth and easy. Finland offers seamless career paths and interesting visiting opportunities. Our diverse international student population and staff pave the way for high-quality research and higher education and respond to the changing demand for expertise throughout the country. Higher education institutions, scientific institutions and other bodies in the sector take the lead in creating an open-minded and receptive society that is culturally and linguistically diverse.

11. Rethinking funding schemes for responsible academic partnerships

Funding agencies constitute important drivers for resolving sustainable development challenges. What they prioritize and how they design, monitor, and evaluate their funding mechanisms has a direct impact on how global academic cooperation is created and fostered. It is in this context that funding agencies have the potential to influence equity and responsibility in academic cooperation. Therefore, UniPID will convene a roundtable to discuss the role of funding agencies/funding instruments for building responsible academic cooperation with actors in the Global South. This roundtable will include representatives of key Finnish funding agencies, researchers and university staff.

In this roundtable we first present challenges that funding receivers are facing under the existing Finnish funding instruments/frameworks. We also present how successful funding applicants navigate these challenges. In the discussion, we want to ask the participants the following questions: How can we ensure that funding supports equal global partnerships? How can we ensure stable funding for global partnerships? How can we ensure flexible and adaptable funding frameworks?

The goal of the roundtable is to have input from a range of perspectives, providing a forum for dialogue, opportunities for idea-sharing and building understanding on promotion of equity and responsibility in North-South research collaborations. A summary of the discussion will be used to interface with relevant stakeholders on the changing landscape in north-south research collaborations.

12. Towards inclusive and responsible language policies in higher education institutions

The session will tackle the issue of language in Finnish higher education and society at large. How can we increase inclusion of internationals in Finland, while at the same time safeguard our national languages? What kind of language policy would be inclusive and responsible?

The first presentation will be held by Sara Backman (University of Eastern Finland), a researcher in "English in coexistence with the national languages in Finland" project. The second presentation will be held by Derek Ruez and Vesna Holubek, makers of the "Survey on experiences of international members of Tampere universities".

The roundtable gathers together central government representatives to elaborate the significance of the [Finnish Africa strategy \(published in March 2021\)](#) to Finnish higher education institutions.

Representatives of the most relevant different ministries, e.g. Business Finland & Center for Education Development Cooperation disclose the relevance of the Africa strategies and related activities in Finnish higher education institutions and capacity building cooperation with African partners. The representatives share their expectations on how the Africa strategy should be visible in the HEI's and how activities of the higher education institutions can be used as a strategic tool for enhancing Finland's policy goals, and what implications this has to the international services of the higher education institutes.

14. Working with the World Bank to reform teacher education and improve the quality of education – Case Kazakhstan

The Vision for strengthening the international dimension of Finnish higher education and research by 2035 (Ministry of Education and Culture, 2022) states "Finland advocates strong national cooperation, which is a prerequisite for impactful international activities". This session presents a World Bank -funded project to support and implement teacher education reform in the Republic of Kazakhstan. As a result of

the project, the national model for initial teacher education was created, 30 competence-based curricula in initial teacher education were revised and developed, and faculties were provided training, mentoring and support in relation to the new ways of implementing teacher education. The project was a significant collaborative effort by two Finnish Universities of Applied Sciences offering teacher education (HAMK and Jamk) and one local university. In addition, the project involved 110 teacher educators and educational developers from 17 universities offering initial teacher education in Kazakhstan. The session describes how this collaboration and work of the large pool of experts was coordinated in various phases of the project and what kind of lessons learnt the project has brought up.

15. Talent Retention: How to support networking with Finnish job market – reflections on services offered; - HEI support services for international researchers and students – one option doesn't suit for all

Finding a job in Finnish labour market is many times based on networks. Supporting the networking of international students and researchers while there are still working for their degrees or research projects is essential. In this session we concentrate on how to bridge the gap between talents looking for companies and companies looking for talents, especially those on doctoral, post-doctoral or master level talents, who are already residing in the region or in the country.

How to run practical applications such as industry placement at companies for doctoral researchers and post-docs or workplace coaching for international talents? How they differ from the support services for international students? Can you offer the same services and which would they be? What kind of tailor-made support or processes you need depending on the field or level of study/research. What kind of models work for each work group? To give background for the discussion, examples are given by Turku Talent hub where universities have piloted different approaches in EU-funded UNICOM project as well as Ministry of Education funded HEI LIFE project among others.

As regions differ, the international talent's views on the opportunities offered and needed for their next career step is highlighted from the point of view from Southern Savo.

16. Diverse and inclusive work communities in higher education: how to get there?

Finnish higher education institutions currently invest a lot of time and effort in Talent Boost work and awareness raising in Finnish society. However, we need to step up the game also in our own sector as employers. Do we attract and hire enough international talents to call ourselves genuinely international higher education communities? What kinds of services should we develop to make the international shift happen on a larger scale and in a responsible, inclusive manner?

In this session the Aalto University and the Universities of Helsinki and Oulu will share practical examples, key learnings and best practices on service development for attracting and retaining international staff and for fostering diverse work communities. The University of Helsinki will first share the learnings on service needs in higher education institutions collected as part of the International Expertise to Work Communities project (Kansainvälistä osaamista työelämään). Next, the University of Oulu will present their multicultural staff training concept which aims to encourage diverse recruitment, embrace the variety of unique backgrounds and competences of international employees and develop successful practices for multicultural teams. Finally, Aalto University will share insights on developing innovative language training for staff in cross-institutional collaboration, highlighting the language needs in the higher education context and the value of language skills for staff commitment. At the end of the session, participants will also be invited to share their views and experiences.

17. Kokemuksia Pathway -ohjelman toteuttamisesta suomalaisessa yliopisto-ympäristössä: Case University Pathway Finland (Science & Technology)

University Pathway Finland (Science & Technology) on ensimmäinen suomalaisten yliopistojen järjestämä Pathway -ohjelma. Se on suunniteltu Opetus- ja kulttuuriministeriön asettamien tavoitteiden, FITech-yliopistoverkoston keskustelemien yliopistojen tarpeiden, taustaselvityksen sekä suomalaisen yliopistoja koskevan lainsäädännön pohjalta. Pathway - ohjelmat ovat yleisiä kansainvälisissä yliopistoissa ja niillä on kysytää kansainvälisen hakijoiden keskuudessa. Kansainväliset toteutukset eivät sellaisenaan ole kopioitavissa suomalaiseen yliopistomaailmaan johtuen lainsäädännöstä, yliopistokulttuurista ja toimintatavoista. Tässä sessiossa esitellään University Pathway Finland (Science & Technology) -pilotin tausta, toteutus, pilottiohjelman kokemuksia sekä ajatuksia siitä kuinka Suomeen integroitumista voidaan edistää jo opintoihin hakeutumisen vaiheessa.

Sessiossa tehdään myös katsaus Kiinaan opiskelijarekrytoinnin kohdemaana, erityisesti Pathway -ohjelman näkökulmasta.

18. Kansainväliset opiskelijat Suomessa – ISB kyselyn tuloksia

Sessiossa tarkastellaan kansainvälisten opiskelijoiden tyytyväisyyskyselyn International Student Barometer (ISB) viimeisimpää tuloksia suomalaisten korkeakoulujen näkökulmasta. Lisäksi esitellään erilaisia tapoja, miten korkeakoulut ovat tuoneet selvityksen tuloksia omaan strategiseen kehittämistyöhönsä sekä kansainvälisen opiskelijoiden hyvinvoinnin edistämiseksi.

19. Korkeakoulujen globaalivastuuallinen yhteistyö - fokusessa Latinalainen Amerikka ja Karibia

Sessiossa esitellään opetus- ja kulttuuriministeriön kv-foorumin globaalivastuuallisen alaryhmän työskentelyn tuloksia sekä sen laatimia suosituksia korkeakoulujen globaalivastuuallisen yhteistyöhön. Aiheeseen johdattelee globaalivastuuallisen alatyöryhmän toisena puheenjohtajana toiminut Johanna Kivimäki, joka työskentelee tällä hetkellä korkeakoululuksen ja tutkimuksen erityisasiantuntijana Suomen Sao Paulon konsulaatissa vastuualueenaan alueenaan koko Latinalaisen Amerikan ja Karibian (LAK) alue. Sessiossa kuullaan myös korkeakoulujen esimerkkejä vastuullisesta, pitkäjänteisestä ja onnistuneesta yhteistyöstä Suomen ja globaalisen etelän kumppanien kanssa.

20. Kuuluuko kansainvälyys kaikille - siis ihan kaikille?

Sessiossa tarkastellaan osallisuuden teemaa kolmesta näkökulmasta:

1. Pedagoginen osallisuus (ToFIE)
2. Erityisoppijoiden liikkuvuuden tukeminen (MOB4ALL)
3. Korkeakouluyhteisön kokonaisvaltainen kehittäminen kohti inklusiota (ICI)

Lyhyet kuvaukset hankkeista:

ToFIE (Laurea):

Tools for Inclusive Education <https://tofie.eu/> -hankkeessa kehitettiin materiaaleja korkeakoulujen opettajille, jotka haluavat päivittää pedagogisia taitojaan ja käyttää inklusiivisia opetus- ja ohjausmenetelmiä. Erityisoppijoiden lisäksi hankkeen keskiössä ovat opiskelijat, jotka opiskelevat vieraalla kielellä. Hankkeessa kehitettiin käsikirja, johon sisältyy käytännön työkaluja opettajankoulutuksen tarpeisiin.

MOB4ALL (Haaga-Helia):

Mobility For All: Innovative Measures to Enhance International Mobility for Special Needs Students <https://mob4all.ulysseus.eu/> -hankkeessa pyritään edistämään erityisoppijoiden mahdollisuuksia kansainvälisyymiseen. KV-asiantuntijat ja korkeakoulujen muu henkilöstö tarvitsevat tietoa erityisoppijoiden tarpeista ja työkaluja heidän liikkuvuusjaksojensa tukemiseen. Hankkeessa on tehty raportti inklusiivisesta liikkuvuudesta. Sessiossa esittemme hankkeessa kehitetyn verkkokoulutusmateriaalin sekä käytännön oppaan korkeakoulujen kv-liikkuvuuden parissa työskenteleville.

ICI (Metropolia): Inclusive Comprehensive Internationalization -hankkeen <https://iciproject.org/> visiona on auttaa korkeakouluja luomaan kaikille opiskelijoille yhtäläisiä mahdollisuuksia kansainvälisen ja kulttuurienvälisten osaamisen kehittämiseen opintojen aikana riippumatta opiskelijoiden taustasta, suuntautumisesta tai kyvyistä. Hankkeessa kehitetään viisi projektitulosta:

- Viitekehys ICI:n toimeenpanolle korkeakoulussa
- Ohje korkeakoulun ICI-itsearvioinnin tekemiseen
- ICI-henkilöstökoulutuspaketti
- Käsikirja ICI-koulutuksen toteuttamiseen korkeakoulussa
- Hyvien käytäntöjen tiekartta.

21. India Collaboration – Novelty, Synergies and Challenges for Finnish Academia

The session plans to open with 2 presentations as a discussion starter for the audience.

- i. A collective presentation by the three Networks (EDUCase Platform, GINTL India and FICORE) on the novelty, synergies and challenges. and,

- ii. A multidisciplinary view on India based on the experience of the Nordic Centre in India (NCI) in connecting the Nordic HEIs with India (The Head of NCI or a speaker from the NCI Secretariat from TUNI).

After the presentations, there will be reflections from a faculty of Indian origin working in one of the Finnish universities and a colleague from one of universities' services who has considerable experience working with India. The Round Table to be Chaired by Mika Tirronen, the TFKN expert for India. The discussion aims to focus on tackling the challenges, finding solutions and in forming a joint vision. The speakers could be from NCI or NCI Secretariat at TUNI, the EDUCASE, GINTL and FICORE Network coordinators, an Academic from Indian origin and a colleague with considerable working experience with India.

What have we learned from the recent events and how should we prepare for the future? How to concentrate on positive aspects of internationalization without losing awareness of risks? And last but not least, what kind of tools and good practices exist already to tackle these challenges? The session starts with two presentations on the two topics, followed by Q&A with the audience. Come and share your thoughts and ideas!

27. Managing expectations and services at arrival stage. How to provide and deliver a matching set of services for incoming international staff and scholars arriving from risky conditions

Motivations of highly educated international talents for arriving in Finland differ a lot. Normally, Finland is the next career step, however, some are coming because they are at risk in their home country. For some, Finnish universities may offer an academic position with the guidelines of International Scholars at Risk (SAR) network. Relocation and integration involve complex and demanding situations. There obviously is a need to adjust the services for incoming internationals from the point of view of different backgrounds.

In this session:

- We open the need for services for incoming internationals from the point of view of different backgrounds and expectations.
- We introduce the recent update on EURAXESS portal which can be used by both HEIs and arriving scholars. We present some best practices for receiving scholars at risk on campus and give examples how to cooperate with SIMHE when supporting integration of international researchers and their families.

28. Internationalisation in transition – learning from the Global Networks experience

As part of its 2021 – 2024 Internationalisation Programme, MINEDU invested EUR 55.6 million to establish eight “Global Networks”, which would strengthen collaboration between Finnish Higher Education Institutions and partners in Africa, China, India and United States of America. The networks were tasked with multiple goals, such as boosting the Finnish brand and creating solutions to global challenges through research, development and innovation. Practically all HEIs in Finland are involved in this undertaking. At the midpoint of the programme, this panel discussion highlights the kinds of strategic services the networks are providing for the internationalisation efforts of Finnish HEIs, as well as some of the main challenges faced by the HEIs coordinating the networks, with a view to forming recommendations for future internationalization efforts. The aim of this Panel is to provide food for thought for those who are engaged in the networks or involved in making decisions regarding future support for internationalisation

29. Vastuullinen ja vastaanottava Suomi - yhdenvertaisuuden ja etnisen monimuotoisuuden edistäminen korkeakouluissa

Suomen tavoitteena on olla vastuullinen ja vastaanottava maa, ja korkeakouluilla on tässä prosessi merkittävä rooli. KOTAMO-hankkeen tulokset osoittavat, että meillä on vielä pitkä matka kohti aidosti yhdenvertaisia ja osallistavia käytänteitä, ja korkeakoulujen tätyy osaltaan kantaa tästä vastuu. On osoitettu, että etnisillä vähemmistöillä on valtaväestöä heikommat urakehitysmahdollisuudet. Haasteita ovat myös syrjintä ja epäinklusivisuus. Työpajassa käydään läpi keskeisiä havaintoja tilanteesta korkeakoulujen näkökulmasta sekä pohditaan hyviä käytänteitä aidosti inklusiivisten yhteisöjen rakentamiseksi.

30. International Employability Landscape; student perspectives from Tampere

Within the framework of the Talent Boost programme, Tampere University aims to develop its facilities and services to support the employability of international students even better. While student surveys give us basic information on students' experiences,

the data inevitably remain on a superficial level. In order to gain in-depth information on students' needs, Tampere University has in partnership with Symbiosis ry, a non-profit organisation founded by Tampere University international alumni, executed a consultation with more than 80 students and alumni to understand students' views on what are the resources and support services which work and what are some of the good practices which have effectively helped students start successful careers in Finland. In this session, we will share the findings of our consultation. Inspired by the findings, we will discuss how universities could support international students' employability even better. The workshop will give an interactive and hands-on opportunity for participants to learn, discuss and brainstorm on effective strategies for developing career services for international students.

33. The Case of Sustainable Entrepreneurship for Climate Action as Example of Mission-driven Global Engagement

Many higher education institutions, also in Finland, have included working for "sustainability" or a "sustainable future" in their mission statements and institutional strategies. But how does that translate concretely into global engagement strategies

and activities? SDGs are not goals that can be achieved at the national or single university level. For this purpose partner universities come together to find the best solutions for an ACTION to achieve SDG and act for net zero economy called a Climate Action. We wish to discuss the case of Sustainable Entrepreneurship for Climate Action funded by Erasmus+ programme in the context of mission-driven global engagement and share best practices achieved within the project and learn from participants good ideas for further actions, as well as to enlarge the network nationally and internationally on set topic. Network widening will also enhance spreading of relevant know-how and support sustainable development at large.

The content of the session:

1. Short introduction to the session theme: Mission-driven Global Engagement and Sustainable Entrepreneurship for Climate Action, what is it and why it is important.
2. Introduction of the research results reflecting current state on Climate Action topic.
3. Introducing the methodologies for Climate Action integration in the university teaching.

34. Finnish HEIs co-creating foundations for responsible China cooperation

35. TALENT BOOST/SIMHE Yliopistojen/korkeakoulujen valmentavat opinnot

Suomalainen korkeakoulujärjestelmä on monille kansainvälisen taustan omaaville haastava. Suomessa opiskelijoita on peruskoulusta lähtien kasvatettu olemaan itseohjautuvia. Monet koulutukset ovat edelleen vain suomeksi tai ruotsiksi. Ratkaisuna erilaisen taustan omaaville on korkeakouluissa lähdetty kehittämään valmentavia opintoja maahanmuuttajille tai polkuopintoja kansainvälisille opiskelijoille. Ammattikorkeakoulujen koulutusvastuulle valmentavat opinnot ovat kuuluneet jo pitkään, mutta yliopistoissa kehitys on nuorta. Yliopistolakiin on suunnitteilla valmentavia opintoja myös korkeakoulujen opetusvastuulle. Helsingin ja Jyväskylän yliopistoissa on valmentavista opinnoista jo parin vuoden kokemus. Ammattikorkeakouluissa valmentavat opinnot ovat tähdänneet opiskeluun suomenkielisissä koulutusohjelmissa, mutta nyt on lähdetty kehittelemään englanninkielisiä valmentavia opintoja.
